19/71 Declarations of Interest

19/72 Police Matters

The Chairman reported that the Parish Office and Library had been receiving anonymous letters which had some unpleasant content. The matter has been reported to the Police and the sender has been identified. The Police have advised that they do not think there is a threat to staff and the sender has been advised to stop sending the letters. Derbyshire County Council have been advised of the issue as they have a duty of care to their staff.

It was reported that a vehicle is parking on the junction of Longmeade Drive, Chapel-en-le-Frith blocking sight lines.

19/73 Open Forum

19/74 M.P., County Councillors, Borough Councillors

It was reported that Derbyshire County Council have issued an emergency number to ring to report roads where tarmac is melting.

19/75 Highways, Public Footpaths, Public Services and Parish Improvements

Members were circulated with details of the proposed Community Involvement Scheme that Derbyshire County Council are looking to develop. Members agreed that the kind of work proposed in the scheme is already been done by the Parish Council.

It was noted that the cuts to the Transpeak Bus mean that there is no direct bus service into Manchester.

The Clerk was asked to report that the old street lights have not been removed from the entrance to Octavia Gardens, Chapel-en-le-Frith.

The Clerk was asked to contact Peak Forest Parish Council to ask them if they have contacted Derbyshire County Council about moving the lay-by sign at Sparrowpit.

It was noted that new banners have appeared on the Market place railings but the commercial banners have been removed.

The Clerk was asked to remind Derbyshire County Council that the brown signs for the Chestnut Centre need removing.
