#### Matters arising - continued

Item 3 Permanent Signs. The Street Lighting department had previously given permission for temporary signage on lamp posts. David has contacted Anna Chapman at DCC about replacing the temporary signage with permanent signage and has received the application form. She also said that funds had been made available for resurfacing part of the Trail. Chris is also looking at possible funding sources.

Item 4 Warmbrook Trail. No news on s106 money and no progress on consulting residents living on proposed route. Awaiting Seddons and Network Rail. Need to wait until after the elections on 7<sup>th</sup> May as DCC Councillors may change.

Item 6 Share with Care Scheme. Chris has been looking for partners to put a proposal to DCC, but it looks like the group will have to push this forward alone. A proposal is intended to be submitted after the election when the DCC Councillors are confirmed.

### 3 Draft Progress Report no 3

Peter summarised the Report, which had previously been circulated. It now includes an Executive Summary and the maps have been made clearer to follow. Conclusions and Recommendations are more fully detailed at the end of the Report. Mave commented that this was a very good report of what the Group had achieved so far.

Peter noted one subsequent minor amendment to one of the Conclusions. He also consulted on the part of the report relating to the Key Cycle Network which needed clarification. Chris will give the report another thorough read through.

David voiced concerns regarding the two new routes on map W8. His advice to the Group on safety is in a professional capacity, and as they are not in Chapel Parish and he has not walked them, he is not in a position to endorse them. He proposed that a sentence is added to the Report emphasising that because these two route options are not in the Chapel-en-le-Frith Parish they have not been scrutinised and remain provisional. Chris encouraged everyone to walk the route.

Peter highlighted recommendations for CPC in the Report, in particular to improve transport connections to the area.

There are still sections of the proposed route for which access permissions need to be obtained and this must now be a priority. It was discussed whether members of the Group or Parish Councillors would be the appropriate people to approach landowners. It was agreed that DCC would need to be consulted. Peter proposed that after the elections Chapel Parish Councillors be approached to help with getting landowner permissions for the route, and also that a register of landowners and progress made with contacting them be maintained. This is a complex issue and support from CPC and DCC is needed.

#### PROPOSAL FOR CHAPEL -EN-LE -FRITH FESTIVAL

In keeping with the agreed aims and published objectives (Neighbourhood development plan 2013-2028 pages 19-22).

I propose a motion for the council to fully support the formulation of a task and finish group reporting to Chapel en Le Frith Parish Council.

The Purpose of which is to develop and implement: - One of two separate options for a festival in the parish in the summer of 2020 or 2023.

This Festival will either be for a weekend or a series of week-long events including the wider parish area. IE Dove Holes, Combs and Whitehough, to be determined by the Parish Council following the recommendations of the task and finish group.

The task and finish group will work in conjunction with and utilise the full support of the existing standing committees IE: - Publicity and communications, Amenities, Planning and regeneration.

This group will invite full participation from members of the community, therefore facilitating parish councillors and interested members of the local community working together for the common aim outlined in this motion. It is hoped that such a group will draw on a wide ranging skill set that exists in the community to enhance the development.

This group will regularly update the progress of developments including any obstacles encountered with the clear expectation that the Council will endorse and offer practical support as the recommendations develop.

The terms of reference of this group will be inclusive, these terms will include the encouragement and support to a range of local community groups in the parish and participation from local businesses including Pubs restaurants and shops participating in the shared objectives.

It will further include engagement with tourist boards, Local media, both radio and newspapers to advertise and make people aware of the festival and events.

In addition the group would engage with relevant agencies including the local police and St Johns ambulance service to ensure key partners are sighted on developments.
