It was noted that the detection rate for crimes remains low at 6% of all crimes reported in the Parish.

A meeting has been organised by Councillor Bannon with the Derbyshire Police and Crime Commissioner and information will be sought regarding policing plans for the Parish.

The new Police Liaison Committee will meet to discuss neighbourhood watch schemes and how members of the public can be encouraged to take ownership of reporting crime.

20/11 Open Forum

A member of the public reported that he had been the victim of a crime which remained undetected for over 2 years and has subsequently been resolved and he is asking the Police to press charges.

20/12 MP, County Councillors and Borough Councillors

It was reported that the light by the Stocks on Chapel Market Place has been repaired.

The first meeting of High Peak Borough Council has not yet taken place.

20/13 Matters relating to Highways, Public Footpaths, and Public Services and Parish Improvements

The Clerk was asked to report the following matters:

- That a number of signs that have been attached to fencing by the Bowden Hey roundabout and on the roundabout itself. It was noted that the Council had not been allowed to elect a green tourist sign at this location by the Highways Authority as it was felt that it would be a distraction to motorists. Derbyshire County Council will be asked to remove the signs.
- Graffiti on a bridge on the A6 bypass.
- The need for better coning of the by-pass slip road into Chapel-en-le-Frith to avoid traffic making u turns.
- Better temporary signage for Blackbrook whilst Sheffield Road is closed.
- The height of the vegetation on the Barmoor Clough roundabout needs to be reduced whilst the diversion is in place to allow better sightlines.

A number of issues were raised regarding the road closure on Sheffield Road:

- If Hayfield Road should be made 2 way with off-site parking being made available for residents whilst the road closure is in place. It was noted that the width of the road would not allow 2 HGV's to pass, parking spaces are used by the Car Repair Garage and there are disabled parking spaces marked on the road.
- Vehicles are ignoring the one way system on Hayfield Road and are also travelling the wrong way on the road by the Parish Church.
- There is a health and safety issue on Hayfield Road East with vehicles unable to turn into the small one way section and causing vehicles to back up on Market Street and also mounting the pavement by the bus stop
- That the temporary one way system should be moved to allow two way traffic to The Crescent.

It was agreed that the situation is monitored and if matters are still causing concern by the next Full Council meeting a meeting will be requested with Derbyshire County Council and the Police Traffic section.

Councillor Young confirmed that he would ask the Planning Officers at High Peak Borough council to check the conditions on the planning consent for work to the veranda on Chapel Market Place.

The Clerk was asked to seek further information from Derbyshire County Council regarding the possibility of widening the footpath in front of the High School on Long Lane, Chapel-en-le-Frith. Councillor Gourlay declared an interest as he owns part of an adjoining public footpath.

A meeting has been held with the High School regarding the all-weather pitch, which is due to be replaced and it was confirmed that the replacement will be like for like to enable hockey to be played as part of the curriculum. It was agreed that other options will be explored to provide a 3/4G facility on site.

The Clerk was asked to report fly tipping by Smithbrook at the side of the Turkish take-away on Market Street, Chapel-en-le-Frith.
