At the commencement of the meeting there were eighteen members of the public and no members of the press present.

Councillor Harrison said prayers.

20/167 Declarations of Interest

Councillor Gourlay declared the following interest:

I declare an interest in the tender process for the sale of the Leys land, as I have a friend who will probably bid if that sale takes place. However, I intend to talk later about the process by which allotment status was removed from the Leys allotments, and I feel I can discuss this with impartiality."

20/168 Co-option Dove Holes and Martinside Ward

Councillor S Young proposed and Councillor Harrison seconded a motion to suspend Standing Orders to allow the three candidates seeking co-option for the vacant seat in Dove Holes and Martinside to speak.

All members were in favour.

The three candidates were Mrs C Cobb, Mr A Cowley and Mr D Phillips.

Mr Cowley advised that he wished to withdraw his application.

A vote was taken with Mrs C Cobb receiving 8 votes and Mr D Phillips 0 votes.

RESOLVED: That Mrs C Cobb be co-opted onto the Council for Dove Holes and Martinside Ward.

20/169 Co-option Chapel East Ward

The Chairman advised that there have been two residents who have applied to be co-opted for the vacancy in Chapel East Ward and that the same process will be carried out having taken due advice from the Monitoring Officer at High Peak Borough Council.

20/172 MP, County Councillors and Borough Councillors

The County Councillor reported that the Highways Officers are working on providing improved signage on Charley Lane.

The work on the culvert of Sheffield Road is running one week late due to resources being deployed to the Toddbrook Reservoir incident.

There will be a consultation over the future of the temporary one way system on Hayfield Road, Chapel-en-le-Frith.

The County Council would not be able to support the introduction of a one way system on Warmbrook Road, Chapel-en-le-Frith.

A site meeting will be arranged with residents in Whitehough who have been affected by recent flooding.

The County Councillor was asked to report on why grass verges in Derbyshire Dales are cut more frequently than in High Peak.

20/173 Matters relating to Highways, Public Footpaths, and Public Services and Parish Improvements

The Clerk was asked to contact Derbyshire County Council again about the depot at Barmoor Clough as it is an eyesore at one of the entrances to the town together with the maintenance of the roundabout.

The Clerk was asked to remind the County Council that the entry signs in Dove Holes that have been defaced have not been replaced.

Derbyshire County Council have advised that temporary fencing has been installed on an unsafe parapet off Sheffield Road.

Issues relating to ground maintenance on South Head Drive have not been resolved and this is a matter for High Peak Borough Council.

It was reported that matters are progressing with the installation of the CCTV camera on the Kings Arms Public House.
