26/158 Public Speaking A member of the public reported regarding an issue with the current building works being undertaken on the viaduct on Hayfield Road, Chapel-en-le-Frith. Repairs have been undertaken to fill gaps in the stonework on the listed building although swifts are currently nesting in the structure. The member of the public has reported this matter to the Transport Police.

poppies at the base and sandbags above with no wording. It was also reported we are still awaiting the draft designs for the interpretation boards.
