The above figure would require a Precept of £114,544 High Peak Borough Council have confirmed that a Council tax Support Grant of £10,107 will be made available and this will reduce the Precept figure to £104,437 and a Parish Rate of £33.57.

Due to the number of new houses in the Parish there has been an increase in the Band figure from 2996 to 3111.

If the Parish rate remained at the 2016/17 figure of £35.45 this would allow an increase in the Precept to £110,284.95.

Councillor Norton proposed a 2% increase in the Precept to take account of the phased reduction in the Council Tax Support grant and the costs of projects for work at the Town Hall and 47/49 Market Street, Chapel-en-le-Frith. Councillor Brook seconded the proposal.

Councillor Harrison proposed a 1% increase in the Precept and there was no seconder for the motion.

The above figure would require a Precept of £125,872 High Peak Borough Council have confirmed that a Council tax Support Grant of £10,107 will be made available and this will reduce the Precept figure to £115,765 and a Parish Rate of £35.91.

Due to the number of new houses in the Parish there has been an increase in the Band figure from 3111 to 3223.

If there was no increase in the Parish Rate of £36.15 from 2017/18 a Precept of £116.511 could be levied.

It was agreed that £746 be added to the Regeneration budget and the following income and expenditure was agreed.

**RESOLVED:** That the 2018/19 Precept be set at £116,511 subject to receiving the Council Tax Support Grant of £10,107 and the Concurrent Function Grant for Parks and Open Spaces of £56,726. This is a percentage increase on 2017/18 budget, but due to the number of extra Band D houses will keep the Parish Rate at £36.15.

# 18/288 Grant Applications

An application was received from the Chapel Business Association to assist with the costs of the Townend Christmas tree and new lights.

**RESOLVED:** That a grant of £300 be made to cover the shortfall in 2017 and to give assistance towards the 2018 costs.

An application was received from Chapel Parish Church to assist with the clearance of Giant Hogweed in the graveyard.

Two quotes were supplied and a grant of £2,500 was requested. However, members were unsure how the figure was arrived at as both quotes appeared to be for the same work. It was also noted that the Church receives a grant of



£500 to help with maintenance of the graveyard which has recently been increased.

Councillor Smith proposed that a grant of £250 be made as a one off grant towards the removal of Giant Hogweed and Councillor Brook seconded the motion. Councillor Young voted for the motion and Councillor Norton against. **RESOLVED:** That a grant of £250 be made to the Parish Church for the purpose of the removal of Giant Hogweed. The Clerk was asked to stress that this is a one off grant in addition to the £500 already made and to note that the Council has a limited budget for grants due to financial constraints.
